U.S. APPROVES THE MILWAUKIE MAX LINE From an OregonLive.com article by Dylan Riviera

In his President's message above, Don Holznagel refers to the necessity in the next year or so to plan for the relocation of our facility. We have known for a few months about TRI-MET'S plans that ultimately would remove our building, but the news this week that The Federal Transit Administration has approved a new stage of development for the 1.4 billion Portland to Milwaukie light rail line makes the plan more of a reality. The following is quoted from OregonLive.com posted on April 1, 2009.

"The administration approved the beginning of preliminary engineering, which means the TriMet transit agency can spend money to plan the details of the light rail line and be assured that at least 50 percent of its expenses will be matched by federal dollars.

"Construction and planning will create up to 12,300 jobs and generate up to \$490 million in personal earnings until the line opens in 2015. Construction could start in 2011.

"The 7.3 mile line will include the first downtown Portland bridge over the Willamette River in more than 30 years, which will handle trains, buses, streetcars and bicycles -- but no cars. The line will run from Portland State University to the Oak Grove area of Clackamas County. Along the way, it will connect several neighborhoods, including the South Waterfront, Brooklyn, Eastmoreland and Sellwood.

"In preliminary engineering, TriMet will spend the next year hiring construction managers, designing the new Willamette River bridge and planning for utility relocations, spokeswoman Mary Fetsch said. Details of what stations would look like should emerge, she said".

The <u>Genealogical Periodicals Index</u> [050 G324] series indexes genealogy magazines from across the country. <u>Ayers Directory 1971</u> [070 A977] lists newspapers, magazines and trade publications by state and city. Information includes founding date, circulation, and often, editor contact information. A special treasure is found in Milner's slim two volume set <u>Newspaper Indexes</u> [070 M637]. Organized by state and city, these volumes list newspaper indexes and their repositories.

WEBSITES TO USE OR RE-VISIT

MISSOURI DEATH CERTIFICATES

Check out the Secretary of State of Missouri's database for your ancestor's death certificates. From 1910-1957, you can actually print off the copy of the actual signed death certificate. I printed off seven of them, giving me death dates for my Gr-Gr-Aunt and her husband whose information I was missing. The pre-1910 database has abstracted information- not the actual certificate. However, the cause of death is there; where their last residence was; cause of death as well as, contributing health factors. You're not looking at the actual death certificate, and you aren't going to find out who the ancestor's parents were. However, you will see what cemetery they were buried in; where their place of birth was (if the informant was correct); if they were widowed, etc., and of course, the death and birth dates.

NATIONALIZATION AND IMMIGRATION RECORDS

Because of the cumbersome, disjointed processes that have created them, naturalization records are some of the most difficult to locate.

Prior to 1906, naturalization could take place in any court of record – at the city, county, state, or federal level; and the various steps of the process might have taken place in different courts across several states.

Since 26 September 1906, aliens have been required to initiate naturalization proceedings with the Immigration and Naturalization Services (INS) and now with the United States Citizenship and Immigration Services (USCIS); followed by other action that could take place in any federal or state court in the area of residence – provided that court agreed to meet federal guidelines.

Post-1906 naturalization documents may exist locally or federally; and the USCIS records of any given event may be housed in the National Archives or at one of their regional branches. Records created within the past seventy-five years are deemed confidential, and those records are therefore closed to the public.

If your ancestor was naturalized after September 1906, the USCIS can find the records for you because all courts have been required to forward copies of these records to INS and now to USCIS. The "USCIS Genealogy Program" permits genealogists to apply online for the records.

Just like naturalization is a two-step process, the application is a two-step process. First you apply for an Index Search (\$20.00). Search results are returned to the researcher, along with instructions on how to request the file(s) from USCIS or the National Archives.

The index search is important because USCIS will check the following record groups:

Naturalization Certificate Files (C-files) from September 27, 1906 to April 1, 1956;

Alien Registration Forms from August 1, 1940 to March 31, 1944; Visa files from July 1, 1924 to March 31, 1944;

Registry Files from March 2, 1929 to March 31, 1944; and

Alien Files (A-files) numbered below 8 million (A8000000) and documents therein dated prior to May 1, 1951.

The second step is to request the records. Given the index search results, you can order the files. The fee is \$20.00 (if the record is on microfilm) or \$35.00 (if the record is in manuscript form).

CAPTAIN ROLAND BROWN'S VISION

"In 1828 or 1829, a debating society was held in a small brick schoolhouse that stood very near the place where now stands the Methodist Episcopal Church. Capt. (*Roland*) Brown was fond of debating, and was seldom absent from the meetings of the society. The subject of railroads and telegraphs was just beginning to attract some attention in the Eastern States. Capt. Brown took up this theme one night, and, enlarging upon it, said the time was not far in the future when railroads would be laid all over the West; that one would reach from Cincinnati to Lake Erie which would not run far from the place where he stood. He added that men would yet travel fifteen miles an hour, and heavy burdens be pulled over these roads by steam power.

"The Methodists were then in dominance in the village. They voted Capt. Brown a *visionist*, a castle-builder, and denounced his railroad theory as the rankest infidelity and contrary to God's revealed word. They claimed that if God had intended his creatures to travel in the marvelous way spoken of, he would have foreshadowed it in the prophecies.

"Of those who were most outspoken in denouncing the Captain's theory, mention is made of John Mitton, Sarah Mitton, Eli Adams and wife, Susan Mitton, Joshua D. Truitt, Benjamin Truitt, James Woosley and his wife, John McCollum and wife, Asbury Houston and wife, Laughlin Kinney and wife, Horatio Murray and wife. No better nor more honored Christian people ever lived in Clark County than these above named; many of them lived to travel by railroad, and the news of the death of more than one of their number was flashed across the land by telegraph."

GFO'S RESEARCH INDEXES GAIN ATTENTION

The <u>Genealogical Forum of Oregon</u> has <u>some good indexes</u> for those of us with Oregon roots. Each index is preceded by an explanatory paragraph or two about the resource. If a copy service for the original document is available, fees and the address is listed. On <u>the home page</u> is a search engine that will search the entire site, the indexes, the catalog, or family histories. Selecting "Indexes," I searched on the surname of Claussen, finding 1 obituary and four marriage citations. Note that the only thing that this search does not search is the <u>WWI Draft Registration Index</u>. You need to go directly to the WWI Draft Registration index to check those.
