

## 15-Year-Old Mystery Solved with Collaboration

On the 1940 census, my father and family are listed as living on Gates Road in South Kelly Butte, Multnomah County, Oregon. I could not find Gates Road on any maps of the Portland area. One day back in April, I was on a Zoom Learn and Chat [Special Interest Group] meeting. I asked if anyone knew how I could find this road. Gerry Lenzen told me there was a large map in the hallway at the GFO that should have this road on it.

I logged into the GFO MemberSpace and submitted a lookup request for someone to look at that map in the hallway for me. I got a quick reply from Doris Cruickshank, who received my request. She used an online map instead of the hallway map. Doris was familiar with the area of South Kelly Butte. She looked on the 1944 Metsker map of Portland online. Doris found Kelly Butte on map 32, but she was unable to locate Gates Road. However, she sent me the link to this map. The map is divided

by areas of Portland. At the bottom of each map, it has a number with the owner of the property listed. How helpful this was!

She told me how to maneuver around this website. One of the great things about this map is when you get to the edge of the map, it is labeled with a number of the continuing map to look at. I started searching each map I felt was close to the area I thought Dad lived in. I finally found a Gates Road on map 40. It was close to Holgate and Powell. I then did a brief search on Google maps for the area around Holgate and Powell, and what did I find? On Holgate and 136th is Gates Park Prop-

## *The McGarvins: Researching and Volunteering Together*

Jerry McGarvin and I were born and raised in the Hood River valley. We married in 1965.

I got my first taste of family history in 1954 after my grandmother, Josie Darden Doggett, wrote her life story, *Our Lives*, after her husband, John, passed away. (Josie's life story was published in the GFO *Bulletin*, in June, September, and December 2019, and March 2020. I had an article about cousin reunion and travels published in the June 2020 edition of the *Bulletin*.) Jerry's intro-

duction to genealogy came from cousins who shared information on both his paternal family lines (McGarvin/Smith) and maternal family lines (Schneider/Hintz/Wiege).

In 1995, I heard about the Lake Oswego Public Library monthly genealogy program and its large genealogy reference section. As Jerry and I began looking through those records, we both became hooked on genealogy. I joined the GFO in 1998, taking

# Find Historical Oregon Newspapers Through Multnomah County Library

Did you know that with a Multnomah County Library card you have online access to *The Historical Oregonian* (1861–1987), *The Oregonian* (1987–present), and the *Oregon Journal* (1902–1982)? These titles are not available through the [Historic Oregon Newspapers](http://HistoricOregonNewspapers) site; although that site does have the *Morning Oregonian* (1861–1937).

To use this resource, go to the library website home page ([multcolib.org](http://multcolib.org)), click “Research” and then click “Research Tools”. A list of available research resources is listed. Library patrons also have access to the historic and current *New York Times*. Other newspapers (generally more current issues) are available through the NewsBank and ProQuest links on the “Research” page.

Many people beyond Multnomah County residents are eligible to get a free library card for the Multnomah County Library.

You can get a free library card if you live, own property, teach, or go to school in the following locations:

### Oregon

- Clackamas County, except for Johnson City
- Hood River County
- Multnomah County
- Washington County

### Washington

- Clark County
- Klickitat County
- Skamania County
- Some areas of Cowlitz County: Cities of Ariel, Cougar or Woodland, Yale Precinct

If none of these apply to you, you may be able to get access to these databases with a Multnomah County Passport card. These cards are available through the Oregon Library Passport Program.

I have found a new Portland resource that is free and easy to use right online. I am so happy I asked the question in the Zoom meeting and that someone was able to lead me

# Former GFO President Accepts VP Position

Laurel Smith agreed to step into the vacant Vice President role shortly after Susie Chodorow became our new President. Laurel sat for this interview with the *Insider* to discuss her new role and her history with the GFO.

## Why did you accept the Vice-President position?

Susie reached out to me and asked me to be Vice President. As a relatively new Board member, Susie thought it would be helpful to have someone with experience on the Board with whom she could consult. Susie also wanted someone to share some responsibilities. I have agreed to fill the Vice President position until June 30, 2022.

## What do you see as the role of the Vice President of the GFO?

Vice President is one of the GFO Board positions that doesn't have a pre-determined set of responsibilities. Traditionally, the VP focuses on a task of choice during their term, or one assigned by the President. There are duties that might be a good fit for the right person. For example, the VP could be the marketing manager. That doesn't mean necessarily creating marketing content, but rather gathering information and making sure it gets out. A dedicated



marketing manager would be a great benefit to the organization. And it should always be a goal for the VP to foster member relations.

## When did you start genealogy?

I started genealogy when *Roots*, the TV show, came out. I did it for the short term, researching my adoptive family. I took no classes. What I really did was family history information collecting. I came back strong into genealogy in 2004 when I found my biological family.

## When did you join GFO?

About 2007. I was Googling my husband's ancestors and up popped a hit on the GFO website. We went down to the GFO, which was then the Gideon Street location, and joined that day. I started volunteering for the GFO in about 2009.

 genealogy classes. Jerry joined in 2002. We became Life Members in 2004.

At the Gideon Building, we attended the quarterly All-Nighter Research program led by Julie Kidd. Other GFO regular members attending were Duane Funk and Jim Rogers.

When the GFO moved to the Ford Building, we began attending several SIG [Special Interest Groups] meetings and a number of GFO seminars. Beginning about 2007 we went on several research trips to Salt Lake City Family History Library and attended several yearly week-long Salt Lake Institute of Genealogy programs.

After my retirement in December 2012, while doing research, Cathy Lauer suggested that I volunteer as a Research Assistant (RA). On my first day as an RA, a patron asked for assistance using Ancestry. Since I had used Ancestry at home, I felt comfortable assisting the patron. After a while, I also volunteered to help process Membership forms with Marge Enneking.

After Jerry's retirement in 2013, we began volunteering as the Wednesday morning RAs. After a year volunteer-

ing, then GFO President Laurel Smith suggested I consider running for the Director at Large position on the Board. I was elected to that position.

At the May 13, 2014, Board meeting, the Board approved a proposal from the Oregon Mentor Corps to help the GFO develop a disaster plan to respond to emergencies. Even before being sworn in as Director, I volunteered to chair the Emergency Preparedness Committee. I had been involved with the Oregon Association of Municipal Recordors (OAMR) since 1983 and knew the OAMR's Records Management Committee had worked with the State Archives on a Disaster Planning Manual that municipalities could use to develop their disaster plans. Rather than reinvent the wheel, I used this manual as the basis for GFO's Disaster Plan and single-handedly wrote that plan.

Jerry began his involvement with the GFO by attending the Family Tree Maker SIG and then working as an RA. He has served as GFO's Facilities Manager. In this role, he has bought and installed new shelving, built many shelving units throughout the library, and moved furniture as necessary. He

has expanded his GFO involvement to working on the Library Committee by indexing Oregon death and divorce records, newspaper obituaries, labeling books, and helping to prepare materials for digitizing.

We have attended many seminars where I staffed the membership table and Jerry was the "chief cook and bottle washer" and clean-up person of the refreshment/coffee area. He also helped with the set-up of seminars and other events and cleanup at the end of the events. Currently, we fold print copies of *The Forum Insider* and put the mailing labels on *The Bulletin*.

In recognition of our service to the GFO, the board named Jerry (Mac) as GFO Star several times and selected us as the Hall of Fame award recipients in 2020.

*Throughout 75th anniversary year of the GFO, The Forum Insider has shared patron memories of our organization and their family history journeys. We would like to thank all the authors who contributed their reflections this year.*

### When were you the GFO President?

I started in 2012 and served for three (two-year) terms. All elected GFO officials are limited to two terms unless the GFO Board specifically asks them to serve longer. The Board came to me and asked me to run.

### What is your other role in the GFO?

My other role is Library Chair. The Library Chair reviews all the materials donated to the GFO. I also select items for purchase in collaboration with the Collection Development Committee. In addition to what we add, we also remove items that are outdated, of little use in genealogy, or don't fit our collection guidelines. I spend most of my time working with volunteers to catalog these new materials and process them for use by our members.

My primary focus right now is our digitization work. I select the materials to digitize. Currently we are not removing books from the shelf to digitize. We want to retain books in our collection for our patrons. We are digitizing duplicates as well as materials that could not be added because of their condition. We are, however, removing periodicals from the shelf to digitize them. Doing so prevents their loss and deterioration and makes them much easier for our members. It also creates much needed space for new acquisitions.

The best part of being Library Chair is working with the wonderful library volunteers. I couldn't (and wouldn't want) to do it without them. They have become my friends as well as colleagues.

Father Scott was researching the Vandehey family and their long journey from The Netherlands,

through Wisconsin, to the Forest Grove area of Oregon.

Ed's grandparents met in Forest Grove, started a family, moved to St. Paul, and ultimately settled in Woodburn. Father Scott authored *Wooden Shoes West* and *On Good Ground* based on his interviews and research. These two books written on their shared family are what started Ed's love and fascination for genealogy.


Now retired, Ed has returned to the family farm and is living in the house he grew up in, one that was built by his father 60 years ago.



# DNA May Reveal Secrets: Be Prepared

We know that DNA is more accurate than genealogy records, which are man-made. Hopefully, everyone who has tested or asked someone to test has informed the tester that their DNA may reveal a surprise. Like genealogy, those surprises vary greatly: from name changes, illegitimate births, adoptions, sperm and ovum (egg) donors...and perhaps more.

Are you or your tester prepared for a possible surprise?

My family has some surprises. Names have been omitted, or the persons mentioned are deceased.

## SURNAME CHANGE

My maiden name is Doolin. I tested a cousin only to discover he not only matched the Doolin surname, but matched six other surnames, even after doing the Y-111. A haplogroup administrator asked me to do the Y-500 test next because this administrator was also matched to these other surnames and had a theory for what was happening. The result was that all seven surnames (and some variations of them) were from the Seven Septs of Laois, a county in Ireland. I had been told all my life that we were Scots-Irish but had no idea from where we hailed.

Years later, my Doolin cousin matched a man living outside of London whose surname is Dowling. I have found no matches to any Dowlings in the United States. After meeting a friend who lives in County Laois at a conference in England, I was told that the pronunciation of Dowling was Doolin. This man authored a book on the Seven Septs and explained that, in 1641, the British were trying to break up the group, causing everyone to either go into hiding or leave the area. I'm stuck in the U.S. in 1750 in Virginia. The Dowling match has his line back to County Laois in 1795, so we are a few generations away from connecting, it would seem.

My Doolin cousin has since died, so I cannot do the Y-700 test.

## SURNAME CHANGES BY CHOICE

A person in my Talley Y-DNA project has his line back to England and matches Talleys. However, his surname is Lorraine. Why the surname became Lorraine when the Talley ancestor came to the U.S is not known. It has been lost in time.

## ILLEGITIMATE BIRTHS

We knew that my grandmother had a child before she was married, and no one knows the father's name. As her son had no male children, no possibilities have been located so far.


My grandmother's brother married a woman, and she bore four children. The family knew that one of the sons (the third child) was from an unknown male. In wanting to DNA test a cousin who was the daughter of the fourth child in this family, we discovered she was not a match to me. She was not my biological second cousin.

Since each of our families had illegitimate children, we tested other family members to see who bore the last name correctly. My second tester proved the surname for my grandmother. The cousin who is no longer my biological second cousin tested her brother and discovered that her father and the third child had the same unique surname...a very unique surname. I told her that her grandmother must have liked the guy as two of her four children, the two youngest ones, were by this unknown man.

## ADOPTION

Several lines in my robust pedigree have surnames of their mother's other marriages. I found an Ogan man living in an area where my Ogan cousins lived, and I tested him. He did not match the surname, and I then discovered his father had taken the Ogan surname from his mother's second husband, Joseph Ogan. The tester and his father carried the biological surname (Abbott) of the wife's first marriage.

I have found women who had their child use the mother's

maiden name because they had not married some cousin of mine or had divorced them. Another case in my family was that a man's father was Walker from a second marriage of my cousin. His mother married again, and the child has the surname of her third husband as do his descendants.

In another instance, my husband's aunt Vivian was said to be the full sister of my husband's mother. Their mother died a few months after Vivian was born. According to the family story, baby Vivian was given to a friend of Charlie (my husband's grandfather) to raise because Charlie had two other children small children and claimed he could not raise a baby alone. After telling this story to the family in Italy, they disputed it. I decided I needed a DNA test. After testing Vivian, I discovered she was a half-aunt. Her mother had an affair with another man while married to Charlie. I was given this man's name by a family member when my mother-in-law died. Sure enough, the young man was living in the home of my husband's grandparents at the time when the half-aunt would have been conceived. I do not know if her children know as I have not seen either of them in years and do not want to bring such a story to them, although it has nothing to do with them.

My family has a sperm donor who has at least 23 children. At least one of the children knows who he is, and this child's mother has spoken with the donor. This young man told me that thirteen of the siblings met in Arizona in January 2020. The young man also told me his biological father's name, which upset his mother, so I have not heard from him since. The donor wants to remain private, and even though he is in his fifties, he has not told his mother. I have known the donor's mother and her siblings most of my life, and I do not want to bring such news to them.

I'm very sure that many of you have discovered secrets revealed by DNA. So, the key here is let all your testers know the possibilities before they test.



## FamilySearch Digitizes All Microfilm

On September 21, 2021, FamilySearch announced that they completed digitizing all of their microfilm—more than two million rolls. The project began in 1998, and FamilySearch reports that the project completion date was 2048. Almost 30 years earlier, records on more than 11 billion individuals have been processed with the help of 30 people using 26 scanners.

FamilySearch accounts are free. To sign up for an account, visit [familysearch.org](https://familysearch.org).

Note that restrictions placed on the digitized content by the record owners may prohibit home access. FamilySearch affiliates like the GFO provide access to more records. While the library is closed, members can request records that are accessible at FamilySearch affiliates via our Lookup Service. Forms for lookups are available in our MemberSpace.
