GFO Beginners DNA Interest Group

Genetic genealogy is the most accurate tool a genealogist has. If you want to discover whether your genealogical paper trail is accurate, and can take some time outside of our meetings to reinforce what you learn, the new GFO Beginners DNA Interest Group is for you.

This group is designed to help attendees understand the basics of genetic genealogy. It will not go beyond the basics, and is a separate set of classes from the previously established DNA group. However, anyone is welcome to attend either group.

The group will meet four times a year: February, May, August, and November. Check the GFO calendar for the dates as they may fluctuate.

The first meeting will be February 27 from 9–11 am at the GFO Library. The topic will be Basic DNA Test Result Interpretation with a Q-and-A session following.

- ◆ Why do a DNA test and how it can help genealogy research.
- ◆ Which tests help with what areas of your pedigree chart.
- ◆ The three types of DNA tests (Y-DNA, mtDNA, and atDNA) and what the results mean.

Family Tree Maker to End Software Sales as of December 31, 2015

Ancestry.com has announced the end of FTM software distribution. Though no more licenses will be sold, the software will remain viable for current license holders through 2016.

From Ancestry's blog: "Ancestry will continue to support current owners of Family Tree Maker at least through January 1, 2017. During this time, all features of the software, including TreeSync™, will continue to work, and Member Services will be available to assist with user questions. GFO's president and FTM special interest group leader, Laurel Smith, advises users not to panic:

Take a deep breath and keep on using it for a month or so to let things settle out. They ARE still supporting FTM for another year, so you don't have to switch right away. A quick response may cause more problems than a slow, thoughtful approach.

To make a smart move, in-depth research will be needed. We will use our group time beginning in January to look at some of the other options, to see how data transfers to other programs, and have other presenters in to show us what they like about their programs.

Some companies are already trying to lure you in with half-price offers. I urge you to resist the temptation. FTM has tools that will allow you to move your tree to other database programs—and we can cover that in our group—but I maintain that it is TOO SOON for you to be taking that action.

So come to the January FTM meeting and make a more informed decision later in 2016. (The FTM SIG meeting is scheduled for Sun, January 17, 2016, 1 pm–3 pm.)

- ❖ www.gfo.org – Our award-winning website is undergoing a total redesign with new features and greater functionality.
- ❖ Operating Reserve Fund – By establishing a policy and setting aside the resources to create an operating reserve, the GFO has gone a long way toward greater financial stability.
- ❖ Disaster Plan – Whether a leaky pipe, injured patron, or earthquake, GFO is better prepared for the emergency. More than a year’s work went into the creation of a comprehensive disaster plan.
- ❖ New GFO Logo – A brand new logo is in the works. Look for the unveiling soon!
- ❖ Library Improvements
 - Vastly increased Internet speed and Wi-Fi
 - New high-resolution microforms scanner with advanced features to help capture and save (or print) microfilm and microfiche images
 - Six commercial databases available in the library
 - Collection development – Our collection continues to grow through the books you donate and by making strategic purchases. Additionally, we have started a campaign to repair or replace our damaged books.
- ❖ Social Media Outreach – We’ve added weekly emails that keep you informed and up-to-date, and we now have regular posts to our Facebook page.
- ❖ Tri-Met Orange Line Event – This event was a rousing success, spreading the word to thousands of celebrants and resulting in over 100 new members!
- ❖ Italian Interest Group – our newest group at the GFO.

2016 GFO Wish List

- ❖ Continue Strategic Purchases and Preservation of Our Collection – We have an extensive list of books we want to acquire and hundreds need repair.
- ❖ Improve Library Shelving – The majority of our library shelves (about two-thirds) are only 7” deep while most of our collection requires 9” of shelf—

or more. Shelves with greater depth will more fully support our books, significantly extend their useful life, and reduce the need for repairs. It's possible to purchase clip-in shelves that will work on our existing framework. We have been looking and will continue to look for used shelving, but we are coming to the realization that we may need to purchase replacements. One new shelf will cost about \$30. That doesn't sound like much until you begin counting up shelves. Replacing all the puny shelves would be a whopping \$19,000! It is unlikely that we could replace them all in a single year, but it would be nice to get a start.

❖ Targeted Use of a Marketing Consultant – Having unsuccessfully sought volunteer help to fill this role, we want to hire a marketing consultant to help us grow our organization, raise our profile in the metropolitan area, and help us focus our volun-

teer efforts. Estimated cost is \$125–\$175 per hour.

❖ Manuscript Collection Scanning – We've settled into our space and will be here for many years. We continue to find ways to utilize the 5,000 square feet we rent; however, the manuscript collections people have donated over the decades continue to occupy too much valuable space—hundreds of cubic feet! And in their current form they are essentially unusable. If we could process these collections, who knows what treasures would be unearthed? We need another high-speed scanner and computer (estimated cost \$3,500), and we need help with the scanning. We are exploring the possibility of an internship program, but we realize we may be faced with hiring a document scanning service.

Explore Your Ancestors’ Lives in Old Newspapers

Newspapers have enormous value for family historians beyond the usual birth and death statistics. Stories and listings “provide more color and context for your ancestors.” An article in Family Search’s blog describes potential findings and ideas for seeing the family in its community through the small as well as the large events.

Topics: Births, marriages, divorces (settlements, children), deaths, name changes, employment (work equipment, commodity prices), addresses (home and land purchases), significant events (new buildings, disasters, crimes), daily life events (out-of-town visitors, gatherings, community organizations), court cases, and immigration (ship sailings, passenger lists).

GFO Nominations for Board Offices

The positions of President, Secretary, one Director-at-Large, and a position on the endowment committee will be up for election this year.

The nominating committee, Harold Hinds and Emily Aulicino, is responsible for finding candidates for president and secretary. Any interested parties may contact them or ask questions at nominations@gfo.org.

After publication of the candidates' names, other nominations may be made from the floor at the March general membership meeting, with the prior consent of the nominee (Article VI:6.3).

The board has "expressly requested that Laurel Smith run again for president" but this does not prevent other candidates from running. (Bylaw 6.9.1 states that: In no case shall any elected officer of the Forum serve more than two consecutive terms except at the express request of the Board.)

Directors-at-large shall be nominated from the floor at the March general membership meeting and/or by written nomination delivered to the Secretary of the Forum prior to the March general membership meeting. Nominations delivered to the Secretary shall be read at the March general membership meeting. All nominations shall be made only with the express prior consent of the nominee (Article VI:6.4).

Other information on nominations:

Article VI: 6.5 Only Individual Forum members in good standing may be nominated for elective office.

Article VI: 6.6 Officers of the Forum shall be elected by written ballot in April of each year.

The term of office is July 1, 2016 through June 30, 2018.

Compilation of Published Sources

MyHeritage.com has announced a new free collection of digitized books. The site contains the scanned pages of over 150,000 publications. The sources are histories, directories, yearbooks, minutes, and more.

The search is easy and free. The basic form includes name, publication title, publication year, publication place, and keywords. The advanced search has options to fine-tune the matching of entries. The result is a bibliography with links to the pages.

Each page is viewable with zoom and pan capabilities, but it's not clear if it can be saved as an image file to your computer. If you have a family tree on the MyHeritage site, the record can be attached to a person in your tree; they will also notify you of potential matches. There is a window with OCR (Optical Character Recognition) translation of the text. You can select, then copy and paste the text to another document. You could also do a screen image capture (I used Snipping Tool) and save it to a file. A test search yielded new and interesting sources.

The Japanese American History Museum's current exhibit is: Gambatte! Legacy of an Enduring Spirit, through January 17, 2016. The museum has permanent, visiting, and temporary exhibits, speakers for groups, guided tours of exhibits, an iPhone app for a walking tour of Portland's Japantown, oral histories (which can be accessed online), and a research library.

The Densho Digital Repository contains thousands of materials on the Japanese American community from the earliest immigrants to modern times, with a major collection on the WWII exclusion and incarceration experiences. Photos, correspondence, newspapers and other sources are available online. Topics cover businesses, arts, sports, families, community events and more.
