The primary surnames covered in this collection include Despain, Hiatt, Bliss, King and Lewis. Primary places traced within the family's genealogical research include Warren Co. North Carolina, Montgomery Co. Virginia, Green Co. Kentucky, and Umatilla Co. Oregon.

# Administrative Information

#### **Provenance:**

The Despain Family History Papers were donated to the GFO Library in 2011 by GFO member Eileen Chamberlin. The original manuscript materials arrived within 1 physical file folder, consisting of 188 pages arranged by the creator according to her progressive genealogical research. According to the correspondence contained in the collection's file folder, one of the creator's primary sources for her research was Robert L Aurnague-Despain from Veneta, Oregon. Additionally, a number of the notes and correspondence included in the collection can be attributed to Wilford W Whitaker Jr. from Prosser, Washington. The dates from Whitaker's notes and letters are primarily from 1970 and the early 1990s.

**Retention and Access:** Scanned images of the collection are currently retained by the GFO Manuscript Committee in three separate digital storage locations and can be accessed via the <u>Manuscript Requests</u> link at the GFO Digital Manuscript website.

**Processing History:** Processing and description of the Despain Family History Papers began in the Spring of 2013 and scanning was completed later the same Summer. Retention of the physical items contained in the collection has been followed in accordance with the GFO Manuscript Committee guidelines. The collection has been kept in its original order as created by its author and her file keeping methods.

**Copyright Status:** The status of copyright in the unpublished writings and research papers of Eileen Chamberlin regarding the Despain Family is governed by the Copyright Law of the United States (Title 17, U.S.C.).

## Scope and Content Note

The Despain collection is comprised of both copied and original source materials, i.e. correspondence, Family Group Sheets, Pedigree Charts, typed obituaries, annotated pages from various published resources, and copies of the death certificates for Jeremiah Boone Despain, Mrs Peaha Jane Despain, Joseph Scott Hurt and Sarah E Hurd. Additional records consist of Oregon donation land claims and abstracts from the family's Revolutionary War pension records.

The collection's annotated materials include the following titles: *Green County, Kentucky Pension Records* as compiled by Annie W Burns Bell, *Kentucky Pension Roll of 1835* published by the Genealogical Book Company, *James Harris Despain: His Family and Descendants* as compiled by Lenna Mae Weaver Weighall, *History of the Pacific Northwest: Oregon and Washington* published by the North Pacific History Company, *An Illustrated History of Umatilla County* by Colonel William Parsons. Copies of the cover pages for these published materials are included in the scanned items for reference and the copyrights remain with the publishing bodies. Several letters and research notes within the collection are attributed to Wilford W Whitaker Jr, editor and publisher of *Despain Log Chain* journal. (NOTE: Several issues from the *Despain Log Chain* journal are available at the <u>GFO Library</u> for additional research.)

Characters of interest within the collection include Samuel Despain (abt 1710- 1783), Jeremiah Despain (1833-1886), and Benjamin Despain (1800-1886), as well as their matrimonial connections with the Hiatt, Lewis and King families. The collection traces the Despain roots from England and Russia back as far as the early 1700's, reporting the family's distinct presence in Warren Co. North Carolina and Green Co. Kentucky after their move to the United States. The collection also records the migration and eventual settling of additional family members west to Umatilla Co. Oregon.
