Abstract: The Greenstreet Collection is a compilation of personal family history research by Evelyn Greenstreet. The most valuable information comes from correspondence with family members and repositories. There are also family group sheets and a few biographical sketches. A small portion of the material relates to Evelyn's volunteer work at the GFO and is not associated with her personal family history. An example is the Bible record of the Yarbrough family that was found at a local bookstore. Prominent surnames within the collection include Greenstreet, Shibley, and Marrs.

Administrative Information

Provenance: The genealogical collection of Evelyn Greenstreet was acquired by the Genealogical Forum of Oregon before 2012.

Processing History: Processing and description of the Greenstreet Collection was completed in early 2021.

Retention and Access: Scanned images of the collection are currently retained by the GFO Manuscripts Committee in three separate digital storage locations and can be accessed at the GFO library or by contacting manuscripts@gfo.org.

Biographical Note

Evelyn Lucille Dibble was born on 5 November 1909 in Estacada, Clackamas County, Oregon. She was descended from Oregon homesteaders. In 1929, she married Clifford E. Greenstreet and they had one daughter. Evelyn joined the Genealogical Forum of Oregon in 1964. She was a regular lecturer for the GFO, and many members received their first genealogical instruction from her. She was inducted into the GFO Hall of Fame in 1989. Evelyn passed away on 22 June 2003 at the age of 93. She is buried in the historic Springwater Cemetery in Clackamas County, Oregon.
