

**INDEX TO ONSLOW COUNTY, NORTH CAROLINA RECORD OF DEEDS, BOOK B, 1779-1785**  
**Abstracted by Stephen Wayne Turner from FHL film #007517542 on FamilySearch.org**

In 1961, Zoe Hargett Gwynn published a 2-volume genealogical labor of love, *Abstracts of the Records of Onslow County, North Carolina, 1734-1850*, which has been an extremely valuable tool for genealogical research in Onslow County for the 60 years since. Almost 70% of the set comprises Gwynn's indexing and abstracting of 47 Deed Books from 1734 to 1839, in itself a monumental achievement. The first 22 deed books, lettered A through Y, with recordings to 1807, are held by the State Archives of North Carolina. These books have apparently been microfilmed by the Archives, but FamilySearch lists no microfilm of them and no online images are available, making access to these vital sources difficult for those like me not near Raleigh. Short of buying microfilms, I've had to rely on Gwynn's abstracts as the best that is practically available, and I have used them heavily, particularly for the 1770s through the 1810s. Many times it has been frustrating not to be able to see the full records. So I was thrilled a couple of years ago to discover that the later deed books, beginning with Book 1 in 1807, can be seen online on FamilySearch.org. Also available there are four newer deed books with copies of deeds from 1734-1806, designated A, B, C and E (FHL films #007517538-007517541). These contain an apparently random selection of deeds copied by hand between 1905 and 1917 from the older deed books, presumably because those were falling into bad repair. A fifth such book designated D appears in the cumulative indexing also available on FamilySearch but it is not among the books accessible there. To the extent the four available on FamilySearch happen to contain a later copy of an earlier deed one needs, they are quite helpful, though inevitably the problem of copying errors is compounded. The four books each begin with a loosely alphabetized grantee index. It is also possible, although rather challenging, to find specific deeds in these through the cumulative indexes, though they appear not to cover book A. The Cross index refers only to Books B-E, generally appearing between books 24 and 25. The main cumulative indexing also refers to a book B-1 that is not found on FamilySearch.

Finding some of what I needed online gave my research a welcome boost, but I was especially thrilled to discover just last year that there is actually one older Onslow County Deed Book also available on FamilySearch, designated as *Onslow County Record of Deeds, Book B, 1779-1785* (the first half of FHL film #007517542). This book covers a mysterious gap in the records Gwynn indexed between Book M, which ends in 1781, and Book N, which begins with recordings in 1785. There are some deeds in Book N dated from the missing years (because of the usual delays between signing a deed and getting it recorded), but my research made it clear the bulk of the deeds from 1782 to 1784 were missing from Gwynn's work. This Book B turned out to contain the missing deeds for these years and some earlier ones that had not been recorded by 1781 in Book M. Note this is not the original Book B that Gwynn indexed (1744-1748), nor is it the Book B mentioned above which contains hand copies of deeds from various old deed books (FHL film #007517539). Nor have I found any evidence of a corresponding Book A. But I am sufficiently grateful for this odd Book B.

Having determined that the deeds in this book were generally not covered by Gwynn's work if at all, I also found that they were not indexed in the two sets of indexes Family Search has for Onslow County deeds, which only cover the deeds starting with Book 1 in 1807 and the selected older deeds later recopied by hand from the original Books A to Y into the later books designated as B, C, E and the missing book D. This Book B dated 1779-1785 does have a loosely alphabetized index of grantees on its first few pages, but it is not quite complete and some of the entries, especially near the top and bottom of the pages, are unclear or quite illegible. Fortunately,

the deeds themselves are usually quite legible, despite the evidence of significant water damage on the top inner quarters of the pages. As I need much information from these records to help in my major ongoing project of dating undated Onslow County tax records, I decided to index this Deed Book B more fully. Starting with an alphabetized list of the grantees based on the indexing in the book, I added grantors, witnesses, and any indications of genealogical relationships. I generally did not include neighbors/adjacencies or previous owners from the property descriptions unless of the same surname as grantees or grantors, or otherwise indicating genealogical relationships.

I decided to very briefly abstract the deeds, adding to the names and page numbers various other elements. For each deed there are typically four or more entries, mostly limited to one line or less:

The main entry is for the **grantee**, including acres acquired, brief indication of location, the (primary) grantor, and date of deed. If the deed shows no date, the term acknowledged in Court or the date of registration is indicated as such. Registration appears to have typically followed the Court order to register deeds by about 3 to 8 months, but in some cases deeds were registered within a month or two, while others took a little more than a year.

A secondary entry is for the primary **grantor**, indicating **S** for sale or **G** for gift, and **CAPITALIZED** name of grantee, from whose entry of the same page number(s) the acreage, location and date can be found. Wives or other co-signers are also indicated. If the grantor sold his own earlier patent or a patent by someone of the same surname, that is also indicated, often with the date of the patent.

For both grantees and grantors, most occupations other than planter, and/or out-of-county residence are included when indicated in the deeds, as well as any stated family relationships.

Entries for **witnesses** (usually two per deed) indicate **W**, or **WJ** for a witness who later acknowledged the deed in court (the J is for Jurat, a Latin term that was applied in that connection, meaning "it has been sworn"). If, as was often the case, the grantor rather than one of the witnesses acknowledged the deed in court, that is not noted in this index. Cross references to the grantee are only included where there are two complete deeds on the same page such that the page number alone would not identify which deed a witness was associated with.

**Slaves** sold or otherwise conveyed, whose given names appear in a record, are listed in the alphabetic list by their given names, with **CAPITALIZED** names of grantee and grantor. In this book every slave mentioned is identified by a given name and in most cases by gender, which I have indicated when given .

Additional entries may be provided for cases where express or implied family relationships or other mentions of interest show up in the land histories or otherwise, and for a few records that are other than deeds, such as depositions, bonds or powers of attorney.

**CAPITALIZED** names in a listing are intended as cross references to other parties mentioned in the record, whose entries for the same page(s) complete or compliment the limited information given in an entry. For example, the grantee is regularly cross referenced in this way in the grantor's entry so one can easily find the thumbnail description of the property conveyed and the date. Names in a given entry which are not capitalized may also have their own entries, but their entries do not particularly give more information regarding the person of the given entry. It's recommended to scan all the entries for any surname of interest and to check all the cross referenced entries.

Many abbreviations are used to keep the entries short; a list of all the abbreviations used (except for abbreviations of names) is included on page 4. Many given names are abbreviated (as is often also the case in the records), such as Wm for William, Danl for Daniel, etc. I have tried to limit these abbreviations to those that are still somewhat familiar to us or that are easy to interpret intuitively and are unambiguous. A few longer surnames have also been abbreviated, hopefully also easy to interpret. Initials (without periods or spaces) are occasionally used in an entry in lieu of a pronoun which might be ambiguous, or for brevity. Titles or designations such as Jr & Sr are indicated when given in a record. In some cases I have supplied a [Sr] or [Jr] in brackets which is not in the record but is intended to be clarifying. Note that Sr and Jr may not necessarily be father and son—they may even be the same person at two different times—and persons with the same name may not be the same person. Variant forms of names in a record may also be indicated in parentheses.

Spelling of names presents a major problem for indexing records of the 1700s, as spelling was not standardized. Especially in the South, spelling by sound could produce odd results, as when Matthew becomes Martha. (For other examples, Cahoon is not unlikely the surname we know as Calhoun, and I suspect Runnels may be a well-disguised Reynolds.) Often the same name is even spelled two or more ways in the same record, for example Ewin(s), which appears in one deed both with and without the final s. (This final s variation is a common phenomenon in old Onslow County records). For purposes of an alphabetical index, I chose for each surname in the alphabetical list a spelling that appears in the records and is likely to be the most familiar or at least recognizable to modern Americans. A very few cross references are given for cases like Ewel/Uel/Youell. Be advised that in any given record, spelling(s) may differ from what I have chosen, but they will hopefully be recognizable as the same name. Within the brief abstracts, the spelling predominant in the record may be given for those names not capitalized, but the **CAPITALIZED** names match those used in the alphabetical listing.

Spelling of place names is similarly problematic, and I have sometimes standardized their spelling when I judged that likely to be clarifying. This index is only meant to be a useful finding tool, and as such does not attempt to achieve consistently the fidelity of exact transcription. I have used [square brackets] to indicate my generally confident interpretation or suggestion of missing or unclear elements, and/or question marks to indicate my uncertainty as to a reading or interpretation. No doubt I will have made mistakes and missed some things as there were many opportunities for error, so rely on your own careful inspection of the records for your own research conclusions. FamilySearch.org has made it easy to see good images of these records.

A note on the page numbering: the pages in this Book B are hand numbered. Page 1 follows the index pages. There are two pages in a row numbered 75, and two numbered 143. There is no discernible number on the page between those numbered 252 and 253, so I considered it a second 252. The image numbers for film 007517542 thus do not match the page numbers given. The Book B page numbers can be translated to image numbers as follows:

For pages 1-75(1 <sup>st</sup> )	add 10 to get the image number
For pages 75(2 <sup>nd</sup> )-143(1 <sup>st</sup> )	add 11
For pages 143(2 <sup>nd</sup> )-252(1 <sup>st</sup> )	add 12

I hope this index with brief abstracting will be helpful to many researchers!
