# ""Early Oregonians Database Index" Added to Ancestry.com and to Oregon State Archives Web Site"

The "Early Oregonians Database Index" was added to Ancestry.com in July. It contains more than 100,000 entries and includes both settlers and Native Americans who already lived in the Oregon Territory. The records start prior to 1850.

You can find the "Early Oregonians Database Index" online on Ancestry.com and also on the Oregon State Archives website at http://goo.gl/Qr9Rvw.

You can read more in an article by Hannah Hoffman in the Statesman Journal website at http://goo.gl/af4NIK. It is interesting to note the article states the price that Ancestry. com paid for the data. "Ancestry paid the state \$1,500 for access to the database, said Layne Sawyer, manager of reference services. The company will make the database available to subscribers, but it is free on the Oregon Archives website for anyone who would like to use it."



# Oregon Trail to be featured in "Who Do You Think You Are"

Not to be missed! On the TLC network and online, "Who Do You Think You Are" ("WDYTYA") features Kelsey Grammer's Oregon roots! You might see some familiar scenes and faces!

# View and Discover the Real Oregon Trail

If the "Who Do You Think You Are" episode inspires a trip to see the emigrants' trails and learn more about the journeys, there are a few interpretive sites located in Oregon. Any of these places would make a beautiful excursion in fall with the leaves turning colors.

Baker City in eastern Oregon is home to the National Historic Oregon Trail Interpretive Center, managed by the Bureau of Land Management. There are interpretive programs, exhibits, and walking trails. Views include remnants of wagon ruts, the Blue Mountains, and the historic Flagstaff Gold Mine. 
On the slopes of Mt. Hood is a section of the Oregon Trail known as the Historic Barlow Road. The area is part of the National Forest and is less developed with a few signs to describe the site. Another part of the Mt. Hood NF trail system is Laurel Hill Chute Trail. Described as one of the more difficult passes for the wagons to negotiate, it's easier to access these days by way of a half-mile hiking trail. http://www.fs.usda.gov/recarea/mthood/recarea/?recid=53406

In the Rogue River Valley, the privately operated Applegate Trail Interpretive Center showcases a segment of the southern route of the Oregon Trail. You may have heard that the Genealogical Forum of Oregon has been working to digitize its manuscripts and family bible collections.

# What They Are and Why

We currently have 91 manuscript collections, with nearly 10 new collections donated just last year, and nearly 30 family bibles. Each of the manuscript collections contains an amazing array of unique genealogical research materials on specific family lines, with original photographs, copies of death and marriage certificates, oversized family pedigree charts, and the occasional collection of correspondence. Scans of the types of items that have been digitized are shown on the next page.

The main goal of the project is to push the valuable content of our manuscript collections out to the public. We want to help researchers from around the country and beyond to access the material on the Internet. While we have been making lots of headway, We Still Need Your Help!

# **Help Wanted**

Volunteer opportunities include organizing and relabeling the paper files, scanning, pulling metadata from the collections, and researching the history of the collections' authors and highlighted families. To reach our goal of fully digitizing all 91 of our manuscript collections and indexing all 28 of our family bibles will take many hands, and the truth is that volunteers like you are invaluable.

So, if you would just love to look through old documents of family histories and help to preserve all of this irreplaceable historical content, please contact

We offer in-depth and easy to follow training and work guides. Once trained, you can work independently to process an entire collection or choose to focus on one step, such as organizing or scanning. Currently, our greatest needs are for help with scanning and data extraction. The data extraction for both the manuscripts and the family bibles, which have already been scanned, can be completed from your home computer using our online forms to guide you.


# What Is A Finding Aid And How To Use One

Finding aids tell researchers what is in a collection, e.g. family group sheets, pedigree charts, handwritten correspondence, death certificates. Our finding aids are geared toward highlighting any information that may assist in an individual's genealogical research. For this reason, we include not only the types of material within each collection, but also provide a list of the most prominent surnames, locations, and date ranges.



Abstract: The McCallment Personal Papers is a compilation of the author's personal family history research. Items include correspondence from Paul Hans Anderson (dated 1968-1994), notated copies from the author's original source materials, a travel journal with snapshots from various graveyards, marriage, census and deed notes. Prominent surnames within the collection include Huff, Vandemark, Alderman, Seay, Leavens, Anderson and Beatty. According to the research contained in this material, the families hailed originally from Germany and Norway before migrating to Rhode Island and New York State. The author's notes evidence that the families later split, some migrating north to Canada, while others journeyed west to various parts of the central United States and eventually to Washington and Oregon.

### Administrative Information

Provenance: The McCallment Personal Papers was donated to the GFO Library in two boxes, with 9 File Folders in Box 1 and 6 File Folders in Box 2. In total, the collection contains 2355 pages. Scanning of the collection was completed in the spring of 2014. The author's original arrangement of the papers has been preserved, and the section titles for each file have been noted throughout the materials according to the author's original notations.

Retention and Access: Scanned images of the collection are currently retained by the GFO Manuscript Committee in three separate digital storage locations and can be accessed via the Manuscript Requests link at the GFO Digital Manuscript website.

Processing History: Processing and description of the McCallment Personal Papers began in late of 2013 and scanning was completed in early 2014. Retention of the physical items of the collection has been followed in accordance with the GFO Manuscript Committee guidelines. To assist in keeping the collection's original order as created by the author, tabulation sheets have been scanned in place of the author's original tab markers to notate the collection's topical divisions.

Copyright Status: The status of copyright in the unpublished writings and research papers of Harriet Virginia Leavens Anderson regarding the McCallment Collection is governed by the Copyright Law of the United States (Title 17, U.S.C.).

# Biographical Note

### Scope and Content Note

The McCallment Personal Papers is comprised of both copied and original source materials. The collection's highlight material includes personal correspondence (Box 1 Files 3-8) from Paul Hans Anderson, addressed to Mrs A, Karen, Jerry and John Joseph Christopher, spanning 1968 through 1994. Other items include various research notes, organized by locations, surnames and topics.

The author's genealogical notations focus on tracing her family's roots through various land and property deed records. While the collection does not include specific biographical sketches, Ms Anderson's notes follow her family's history back to the Leavens to the Aldermans, the Seays, the Beatties, the Huffs and farthest to the VanDemarks. The research shows evidence that the author's family was originally from Norway and Germany, before

they immigrated to the North American continent, setting in various areas of New York and Rhode Island with some later moving to New Brunswick, Canada.

# Volunteers Needed to Assist with Disaster **Recovery Efforts**

The Disaster Response Preparation Committee has been working since late May to develop a response plan for the GFO. At a recent board meeting, the Board of Directors approved a new incident report form that will replace two outdated forms to report incidents that occur within the Library.

The Committee has been working on two major projects:

- 1. Developing a guide which details procedures to follow and who to contact in an emergency situation. This project is nearly complete.
- 2. Developing a disaster plan. We are using an online disaster planning tool called dPlan which guides non-profit organizations in creating disaster plans. The first step was to conduct a risk assessment of the GFO library and offices, but also the Ford Building as the condition of the building affects the GFO facility. The committee is identifying priorities regarding the GFO collection and organizational records to prioritize items to be salvaged.

In the event of a "minor" disaster, one caused by water leaks, breaks in water pipes, or fire sprinklers that go off on their own, the GFO will need volunteers to assist with cleaning up the library or salvaging our collection. If you are able to assist in an emergency we need your commitment to **help!** We are preparing a list of members we can call to come in and help with cleanup and salvage in an emergency.



# **Treasurer's Report**

August income totaled \$6,605.18. Picnic collections were \$153, there was \$70 in general fund donations, \$31.56 in Vanguard dividends, \$1787 from annual memberships, \$1,889.00 from the Fall Seminar, \$240 from the Garden Tour (Thank you!), \$885 for the Lenzen half day seminar. \$151.47 from the reading room, \$31 from research, \$55.58 in Amazon commissions, \$22 from publications, and \$1,289.57 from used book sales.

# **Data Extraction Projects**

The Oregon births (bound) from 1903–05 that are indexed at the state office are being consolidated. Multnomah County marriage books are the second project searching for volunteers. The two phases are data entry and proof-reading. There are 5 books dating from November 1912 to May 1915. These records will be placed on the GFO website.

Open to Members and Visitors


