PRESIDENT'S MESSAGE—

Dear Members,

A busy, exciting time is upon us as we prepare for the move to our new space, and watch the razing of the current building to prepare for the new light rail line extension to Milwaukie.

Mid-July thru Mid-August is the estimated period for our great move over to the new location in the Ford Building on S.E. 11th Avenue and Division Street. The lease was signed on April 7th, the preparation work for painting and the actual painting of the walls and ceiling was accomplished in May and early June. The HVAC, electrical and internet connections were the next focus as I wrote this message. Relocation Chair Don Holznagel will continue his updates in the Insider newsletter as we move ahead.

The moving of the shelving, furniture and books, etc. will be accomplished with professional movers who have had recent experiences such as moving the Portland State University library collection to its new location, as well as the move of the Portland Archives collection. TriMet/Federal Funding will cover that cost. There will be plenty of other miscellaneous stuff for us to move, and we thank those volunteers who have signed up to help with the upcoming move. Bless you all. Although we will be open toward the end of August, a Grand Opening will probably happen in September. So keep posted, check out our newsletters, and the GFO website. (www.gfo.org)

Our two new interest groups—Virginia Group and German group—have gotten off to a flying start with a wonderful response to the announcement. Since an amazing number of the German group also signed up for the Virginia group, they met and made plans to meet on the same day each month—the 1st Saturday of the month from Sept to June. Plans need to be firmed up for this group, as well as confirming an earlier offer for a co-leader.

April 2011

Income for the month totaled \$10,850.48, expenses \$12,306.84 with the checking account balance at \$30,509.59 on 4/30/11. The activity for the month including the payment of the \$6,000.00 deposit for our new site, the balance of the income and expenses for the Spring Seminar and a deposit into our bulk mail permit account at the USPS. Redside, our landlord, did not take their automatic rent payment for the month which will cause two rent payments to be deducted in the following month.

May 2011

Income for the month totaled \$3,923.27, expenses \$7,600.98 with the checking account balance at \$26,831.88 on 5/31/11. Moving Ahead

Not only is the moving of GFO ahead, but it is in sight and coming up fast. By the time you read this, the contractors will have installed the phone/data lines, electrical wiring and lights, and heat/ventilation/air conditioning systems at our new space at the Ford Building. The remaining work is mainly for GFO volunteers, including painting office spaces, and cleaning and sealing the cement floors. At this writing, the prep for doors is complete and the trench by the south wall is filled. Some lighting will not be installed until July.

Judi has done a super job with painting but she will be gone for two months. We urgently need someone with experience to supervise the floor cleaning and application of sealer. We need it done probably in the second or third weeks of July after all other work is done. We will also need a work crew. I don't know any member with the knowledge to lead it, but we sorely need a leader at this time.

We also need a paint leader and crew in the first or second week of July to paint an office interior, the new HVAC closet, the wall fill-ins, and do any touch-up. This is also urgent because we will have little leeway at that point. Announcements in the Insider Extra, on e-mail lists and at the library will specify dates, times, and volunteer needs to finish remaining tasks.

We still expect the actual move to occur the last week of July and the first week of August. It takes two weeks to move because of the staging of bookshelves necessary to complete the seismic anchoring now required in building codes.

Onward to August in the Ford!

Don Holznagel**

The following was read at the Annual Meeting, June 11, 2011

In honor of service to the Genealogical Forum of Oregon, we are inducting a member of our organization into the Hall of Fame in recognition of his outstanding service to the GFO.

Our nominee this year has been a member since 2001 and has packed many responsibilities into that ten year span.

He began his service as a reading room assistant on Fridays and manned the desk for the 4 – 8 pm shift until he was convinced to lend his considerable leadership skills to our organization by serving as President from July 2007 to June 2009.

During his tenure as President he was instrumental in creating the Technology Committee which provided our library with new and upgraded computers, software and website improvements in May 2008. We continue to budget for replacement equipment each year based on the plan developed by this committee.

During this time period, the Editorial Director positions became vacant and our nominee was instrumental in leading the drive to find her replacements for the publication of the Bulletin. The membership chair also became vacant at this time and he again stepped in to successfully recruit a new chair.

Additional accomplishments include the adoption of our current by-laws, a much needed fee increase to our dues structure to help balance the budget, coordination between the special interest groups and serving as a part of the Grant Writing Committee sharing known resources and ideas for future grants.

He is a leading force for our organization and a nurturer of the volunteers and tasks our group takes on. One of his proudest achievements was the high percentage of volunteers that we enjoy from our membership which was 11% in 2009.

Another important committee created during his tenure originally met to research the future of our organization and discuss possible options for the library's holdings if we downsized our location or holdings. This was a timely committee as the news reached us that TriMet was going to build a new light rail line from Milwaukie to Portland in early 2009 which would require us to move for a fourth time.

Because of the challenge of finding and moving our library to a new site that would be adequate in size and also budget friendly in cost, this task required a person with proven leadership skills. Our recipient agreed to remain active after his term as President and accepted the appointment to chair the Relocation Committee (much to the incoming President's relief!).

The GFO is indebted to him for his leadership and time commitment to lead us into the future in our new home. He has been instrumental in working with the realtor to arrange the viewing of properties, coordinating the lease proposal and signing of the lease with our new landlord, the bidding and selection of the subcontractors for our improvements and general oversight of the entire project from inception to completion.

Please join with me in applauding the recipient of the GFO's 2011 Hall of Fame award – **Don Holznagel!**
