This presentation will help you maximize your experience with each of the four major autosomal DNA tests available: Family Tree DNA's Family Finder, 23andMe, AncestryDNA, and MyHeritage's DNA test. Family Finder, 23andMe and Ancestry.com's AncestryDNA test are the three leading autosomal DNA tests used for genealogical purposes and MyHeritage has also recently entered this market. Genealogists need to know the pluses and minuses of each of these tests and how to best apply the test results to their personal genealogical research.

## 12:30 - 1:30 Examples of How Autosomal DNA Testing Solved Genealogical Problems – Tim Janzen

Autosomal DNA tests can help you verify your family tree and also allow you to discover new ancestors. This presentation will provide multiple examples of how autosomal DNA testing was used to tackle genealogical research puzzles that could not be solved using traditional genealogical research. Some of the case studies will demonstrate how autosomal testing can reliably establish close genealogical relationships while other examples will describe how genealogical relationships 5 or more generations back in time were confirmed.

### 2:00 - 3:00 The Power of GEDmatch, a Third Party Autosomal DNA Tool – Lisa McCullough

GEDmatch.com is a third-party website that has many useful tools for comparing autosomal DNA test results from the various DNA testing companies. GEDmatch accepts autosomal data from the four major testing companies; however, if you have tested with AncestryDNA, this website is vital in helping you see which DNA segments you share with others. This presentation will cover the basic tools and site navigation of GEDmatch.

#### 3:30 – 4:30 *Introduction to DNAGEDCOM* – Richard Weiss

DNA analysis requires the use of third party tools to be effective. This presentation is an introduction the tools at DNAGEDCOM including the DNAGEDCOM Client, Autosomal DNA Segment Analyzer, GWORKS, JWORKS, and KWORKS. *This topic is not recommended for DNA beginners*. The attendees will have: 1) an understanding of what each tool is used for, 2) how to set up each tool for use, and 3) where to get help.
