GFO maintains a research library with over 56,000 holdings serving the entire Pacific Northwest. The library is normally open to both GFO members and the public. In most years, hundreds of patrons use the library in-person, but in 2021-2022 the physical library was closed over 200 days due to the Covid-19 pandemic and patronage is still recovering. We continue our online offerings. In this fiscal year we had 2300 unique visitors each month on the website. Another ongoing initiative is digitizing materials, especially one-of-a-kind holdings and publications at risk of deteriorating; this year we made over 100,000 additional pages of images available to members online.

The GFO holds numerous classes and workshops during the year to teach people how to trace their own family histories. Conducted a week-long conference online with 19 educational sessions. Hosted over 100 special-interest group meetings throughout the year. Published a quarterly genealogical journal.

The library Collection is the only asset that falls within this definition of "collection". Accordingly, the Collection is not shown on the balance sheet nor is it depreciated. FY2023-24 amounts: Estimated beginning value \$2,756,279; purchased items accessioned 666; donated items accessioned 4,500, de-accessioned items 150, insurance recoveries 0; estimated ending value 2,761,295.

Schedule D, Part III, Line 4 - The GFO possesses over 56,000 holdings in its permanent collection of historical books, periodicals, and original records. A primary objective of the organization is to preserve and share historical published material and records for genealogical research. The entire collection is available to researchers (including non-members), and we offer educational classes each year to help people learn to use this collection.
