**Abstract:** The collection includes correspondence and documents collected by Naomi Shelley. There are copies of many primary sources relating to the births, marriages, and deaths of both immediate family members and some ancestors. The collection includes personal correspondence and biographical sketches.

The primary surnames are Boyed, Shelley, and Johnson. The primary location is Oregon.

## Administrative Information

**Provenance:** The genealogical collection of Naomi Boyed Shelley was acquired by the Genealogical Forum of Oregon before 2015. The files were originally labeled the Catlow Collection. However, that name does not appear anywhere in the files. Most correspondence is addressed to or related to Naomi Shelley, so it is presumed that she was the original collector.

**Processing History:** Processing and description of the Shelley Collection began in late 2015 and was completed in 2022.

**Retention and Access:** Scanned images of the collection are currently retained by the GFO Manuscripts Committee in three separate digital storage locations and can be accessed at the GFO library or by contacting [manuscripts@gfo.org](mailto:manuscripts@gfo.org).

Naomi Julia Boyed was born 5 October 1891 in Heppner, Morrow County, Oregon. Her parents were Louis Daniel and Dora Alice (Baird) Boyed. Naomi married Albert Shelley on 2 January 1910 in Hood River, Hood River County, Oregon. They had three children. The marriage ended in divorce. Naomi lived her entire life in Oregon. She died on 3 October 1987 in Washington County, Oregon.
