Follow the Footnote

Recently I was able go from an unsourced, one sentence snip that had been posted on *Ancestry* to a six-page narrative about a family's life as enslaved people in 1860s Texas. How? By following the footnote.

The research subject was Flint Campbell, born just after the Civil War in Harrison County, Texas. His parents, Lewis and Mariah, were born into slavery, as were several of their children. A fellow researcher had posted this unsourced snippet:

just as they had done before emancipation. Simpson Campbell, who had been born a slave in Harrison County, Texas, in 1860, recalled, "One of the oldest fiddlers of slavery time teached my brother Flint to play the fiddle."

Flint had a brother named Simpson. Simpson participated in the oral history project *Born in Slavery: Slave Narratives from the Federal Writers' Project, 1936 to 1938*. Those narratives, including the one by Simp Campbell, were on *Ancestry* and on the Library of Congress website.



GivingTuesday Marriage and License Index Now Available

On November 30, 2021, the GFO held a first-of-its-kind GivingTuesday event. We asked our community to join us for one day—online—to index Multnomah County license and marriage records. Seventy-five volunteers indexed 935 pages. Several participants enjoyed themselves so much that



After several months of continued indexing and review, we are thrilled to announce the index for volumes 40 and 41 are now available on our website. "Marriages 1916—1920" is different than earlier indexes because the "Year" column may contain a date for the marriage or simply a license. In addition, a "Comments" column was included to indicate "No Returns" or "Cancelled."



"There were so many no returns I wanted to make sure the comments were entered," said Data Extraction Chair Loretta Welsh.

Once a couple obtained a marriage license, the officiant was expected to return a form with the marriage information. "No Returns" indicate situations where the marriage did not take

place or an officiant never returned the marriage data.

Fifteen of the GivingTuesday volunteers are continuing to index volumes 42–56 and 60. (The GFO was not able to obtain volumes 57–59.) The indexers are currently starting on volume 52, so more will be added to the website index as soon as they are proofed.


To obtain copies of the license and marriage record, you may submit an *order form*. Members may log into MemberSpace to request a copy from a Lookup volunteer.

However, the two-page entry did not include the above sentence about Flint. So where did it come from?

I searched part of the sentence, in quotes, in <u>Google Books</u>. I found it on page 312 in the book *A Question of Manhood: A Reader in U.S. Black Men's History and Masculinity*. So, what was footnote 46? The source list was not included in the preview in Google Books. However, the Table of Contents revealed that the book was a collection of essays and that page 312 was from the article "Black Musicians from Slavery to Freedom" by Paul A. Cimbala, published in *The Journal of Negro History*, Winter 1995. So, I searched for that. The second result led to the article through JSTOR, which I was able to access through the *Multnomah County Library*.

Finally, footnote 46. It read: Rawick, ed., *American Slave*, supplement series 2, vol. 3: Texas Narratives, pt. 2, 612, 614. So, I searched for *that* book on Google Books. Found it, but the results were only snippets.



Next step, <u>WorldCat</u>. Here, it became very frustrating. My initial results were in Dundee, Scotland, and Kentucky. Because there were different titles, series, and volumes, I eventually just searched for the author/editor. I found the books at two local colleges, Reed and Lewis and Clark. The catalog entry at Lewis and Clark looked more promising, so I sent off an email. A research librarian replied within a day and sent me copies of the relevant pages.

These pages contained the full narrative of Simp Campbell, with three additional pages of information about his and his family's lives...including more of the note about Flint. Was it worth the time and frustration? Absolutely.

made. The banjoes was made of round pieces of wood, civered (covered) with sheep skin and strung with cat-gut strings. One of the oldest fiddlers of slavery time teached my brother Flint to play the fiddle. The only ring play I 'members is:

"Ellen yards, seven stars

Dolls going to fall

Ellen yards, seven stars"

Addendum: While searching for information about the lyrics in the narrative, I stumbled upon an old *Rootsweb* site where Eleanor Wyatt had transcribed the entire narrative. This did not show up in any previous search. Her site includes transcripts of the slave narratives from Texas and Oklahoma, as well as many documents related to "Freedmen and the Five Civilized Tribes."



Important Changes Made to Find a Grave®

After my mother died five years ago, I went to the *Find a Grave* website to submit her memorial. ("Memorial" is how *Find a Grave* refers to the webpages of a grave on their site.) It was about three weeks after my mom had



passed that I looked online and found that her memorial had been added by someone totally unrelated to our family. And, as many other families had experienced, some of the information submitted was incorrect. In this case, her parents' names were incorrect!

After receiving input from many people like myself, on January 11, 2022, *Find a Grave* announced changes to the memorials for the recently deceased.

"During those first three months after the death date (when the memorial displays with a limited view), we have added a simple way for close relatives to request to manage the memorial. A close relative can click the 'Manage' button, add their relationship, and become the manager for a new memorial for that person. The option to 'Manage'


can be found on the memorial and in memorial lists. Since the manager is related, the memorial will now display and act as any other memorial. You can choose to make your relationship public or private.

To request to manage a memorial for someone you are related to (within our updated transfer guidelines) who has died in the past year, select (Manage) and go through the process to become the manager of the memorial."

There is also information on how to transfer management of a memorial that is older than three months on the website. This is an important issue, not only for those who find incorrect information on their relatives' memorials, but also for those who document their family tree information on *Find a Grave*. Memorials that have parents and children of the deceased listed are a public service to others searching for ancestors.

Thank you, *Find a Grave*, for this important improvement to your vital website.

GFO Joins 1950 US Census Community Project



The Genealogical Forum of Oregon has joined forces with genealogy societies and organizations around the country as part of the 1950 U.S. Census Community Project.

The initiative will publish a free, online, searchable name index of the 1950 US census after images of the census are released to the public in April 2022. This online index will offer family history researchers a rich genealogical data set for their ongoing use.

FamilySearch and Ancestry launched the initiative in the fall of 2021, and the project is already engaging thousands of volunteers to help provide this invaluable resource to family historians around the world.

The index created by the project will allow the public to easily search every person found in the census and view digital images of the original census pages where individuals are listed. The highly anticipated 1950 U.S. census will

be the most popular U.S. record collection released to date.

"The 1950 census is attractive to both new and experienced researchers because most people in the United States can remember a relative that was living in 1950. It will do more to connect living memory with historical records and families than any other collection previously made available," said David Rencher, Chief Genealogical Officer for *FamilySearch*.

The 1950 US Census Community Project is also receiving support from leading societal organizations like the National Genealogical Society and other societies around the United States.

Vital Records For City of New York Released

The New York City Municipal Archives has digitized more than nine million vital records—with a goal of reaching 13.3 million—and made them freely available online. Birth, marriage, and death records are available for all five boroughs. Coverage varies by type of record and borough. To see what is available and what remains to be digitized, visit the *Digital Vital Records* page.

The database can be <u>searched</u> by certificate number, names, or browsed by year and borough. Note that this site is still in progress: many records are not indexed, and it is not possible to search for name variations at this time.

During the February meeting, we discussed William M. Litchman's article, "The Identity of Three-Times Convict Henry F. Neher of California, Colorado, Illinois, Kansas, Nebraska, Nevada, Ohio, Oregon, and Texas," NGSQ 108

(Mar 2020), p. 59–68. Proving identity when there is more than one person with the same name can be difficult, but we felt that Litchman did so successfully. The detailed chronology of Neher's life events and his repeated patterns of behavior separated this Henry Neher from the others, despite the lack of many primary sources of information. Newspapers certainly came in handy when court documentation of divorces were not available.



And, in case you missed the American Ancestor's webinar of Melanie Mc-Comb's "Wanted! Dead or Alive: Researching Criminal Ancestors," it is available free on YouTube. There were a lot of great resources for finding information about ancestors with crimi-

nal pasts.
